

OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.

A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1) **Sweepstakes Timing:** The P&G Everyday Receipt Validation Sweepstakes (the “**Sweepstakes**”) begins 12:00 a.m. Eastern Time (“**ET**”) on 6/1/2019 and ends at 11:59 p.m. ET on 6/30/2019 (the “**Sweepstakes Period**”).
- 2) **Eligibility:** The Sweepstakes is open only to legal residents of the 50 states of the United States and the District of Columbia, who are 18 years of age or older as of the last day of the month prior to date of entry. Employees of The Procter & Gamble Distributing LLC (the “**Sponsor**”), their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, including Don Jagoda Associates, Inc. (“**Administrator**”) and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win. - 3) **How To Enter The Sweepstakes: There is NO PURCHASE NECESSARY to participate in the Sweepstakes. A purchase does not increase your chances of winning.**
 - a) **To Enter Via Purchase:** During the Sweepstakes Period, if you make any purchase from a participating retailer (listed in the chart in Rule 4) you may enter the Sweepstakes by visiting pgsweepstakes.com and completing the on-screen registration form, including uploading a photo of your receipt, to enter the Sweepstakes. If your receipt includes one (1) Procter & Gamble product, you will receive two (2) entries into the Sweepstakes. If your receipt includes more than one (1) Procter & Gamble product, you will receive three (3) entries into the Sweepstakes. Limit three (3) entries per receipt regardless of how many Procter & Gamble products are listed. Limit eighteen (18) Purchase entries per person. Each receipt must be unique to enter online. All entries must be received by 11:59 p.m. ET on 6/30/2019.
 - b) **To Enter Without Making A Purchase:** To enter via mail, on a plain piece of 3”x 5” paper hand print your first and last name, street address (no P.O. Boxes), city, state, zip code, month/year of birth and email address. Mail your entry in an envelope no larger than #10 (business-size envelope) with sufficient postage affixed, to: P&G Everyday Receipt Validation Sweepstakes Entries, P.O. Box 7767, Melville, NY 11775-7767, to receive three (3) entries into the Sweepstakes. Mail in entries must be postmarked by 7/1/2019 and received by 7/8/2019 to be eligible. Do not mail more than one entry form in a single mailing envelope. Limit three (3) entries (one entry form) per mailing envelope. There is no limit to the number of mail-in entries you may receive but each envelope must be mailed separately. No mechanically reproduced/photocopied mailed entries permitted. Sponsor is not responsible for lost, late, illegible, mutilated, postage-due, misdirected entries, or entries not received in time for the random drawing.

- 5) **Privacy:** Trust is a cornerstone of Sponsor’s corporate mission and the success of their business depends on it. - 6) **Random Drawing and Winner Notification:** The random drawing to select one (1) Grand Prize winner will be conducted on or about 7/9/2019, from among all eligible entries received by the end the Sweepstakes Period. The drawing will be conducted by the Administrator (at their office in Melville, NY), an independent judging organization whose decisions are final on all matters relating to the Sweepstakes. Odds of winning the Grand Prize are dependent upon the number of eligible entries received by the end the Sweepstakes Period. The potential Grand Prize winner will be notified via email and will need to confirm their eligibility within five (5) days of receiving the notification. If the potential winner doesn’t respond within five (5) days they may be disqualified and an alternate winner may be selected. Return of any prize/prize notification as undeliverable may result in disqualification and an alternate winner may be selected from remaining eligible entries received.
